


Ladies and Gentlemen:

On or about September 30, 2010, Chrin Brothers, Inc. (Chrin) will submit a Major Permit Modification Application to the Pennsylvania Department of Environmental Protection (DEP) Waste Management Program, Northeast Region, requesting approval to expand the municipal waste landfill permit boundary for the Chrin Brothers Sanitary Landfill located on Industrial Drive in Williams Township, Northampton County, Pennsylvania. The application requests approval to expand the permit boundary by approximately 4.3 acres to formally incorporate portions of contiguous properties traditionally used for site support activities into the site's existing Municipal Waste Management Permit. The proposed project will not increase the waste disposal area or volume, or waste acceptance rates. Following approval, the expansion area will include a new facility entrance, landfill office and scales, and a leachate storage tank.

Copies of the application will be available for review and copying at the DEP Wilkes-Barre Regional Office. Fees for copying may be charged by the DEP. Copies will also be submitted to the Williams Township Municipal Building on Cider Press Road and Northampton County at Northampton County Government Center, 7th and Washington Streets, Easton, PA 18042, and Lehigh-Valley Planning Commission on Marcon Boulevard, Allentown, PA 18013. Williams Township and Northampton County may submit comments to the DEP within 60 days of receipt of the application, recommending conditions upon, revisions to, and approval or disapproval of the application, with specific reasons described in comments. The DEP will also accept comments from the public during the permit review period. Comments should be sent to the attention of Mr. William Tomayko, Regional Solid Waste Program Manager, Wilkes-Barre Regional Office, 2 Public Square, Wilkes-Barre, Pennsylvania 18711.
